#### About us

# Information we collect about you

We collect and process the following information about you:

- Information you provide to us. You can provide us with information about you by filling in forms on our website or by contacting us by telephone, email or otherwise. - **Legal obligations.** It is necessary for us to process your personal information to comply with the law.

## **Sharing your personal information**

We may share your personal information with third parties in the following circumstances:

#### Cookies
